2 DESCRIPCIÓN GENERAL DEL PROYECTO

- Actuación:
Reforma de las instalaciones de alumbrado público exterior por tecnología LED e implementación de un sistema de telegestión, en el municipio de Puebla de Don Fadrique.

2.1 IDENTIFICACIÓN DE LAS INSTALACIONES MUNICIPALES AFECTADAS

- Ubicación y descripción técnica:
Las instalaciones municipales afectadas se ubican en el municipio de Puebla de Don Fadrique (Granada). Concretamente se corresponden con las instalaciones de alumbrado público exterior del núcleo urbano de Puebla de Don Fadrique y del núcleo de Almaciles.

2.2 DESCRIPCIÓN GENERAL DE LAS INSTALACIONES MUNICIPALES AFECTADAS

Los centros de mando de alumbrado son los siguientes:



CMA 007, CMA 008, CMA 009, CMA 010, CMA 011-017, CMA 016, CMA 019, CMA 020, CMA 021, CMA 023, CMA 024, CMA 025, CMA 026, CMA 027, CMA 032 y CMA Norias.

Se definen, a continuación, las actuaciones ejecutadas por cuadro de mando:

- ✓ El **CMA 007, con CUPS ES0031104611522001MR0F**, tenía conectadas un total de 66 PL, según se indicaba en proyecto técnico. Durante la ejecución de los trabajos se ha detectado que la luminaria con código 834 no está conectada al centro de mando, es una luminaria particular. Además, se han detectado 2 PL no contemplados en proyecto técnico. Por tanto, el CMA 007 tiene conectados un total de 67 PL. **De los 67 PL existentes en el centro de mando, se actúa sobre el total de PL del cuadro.** Por tanto, el estado actual tiene 67 PL, que se sustituyen por 67 PL en el estado reformado. Con modificación con respecto a proyecto, ya que estaba previsto instalar 60 PL y finalmente se han instalado 67 PL. 59 PL cuya instalación estaba prevista en proyecto + 2 PL que se han detectado durante la ejecución de los trabajos + 6 PL que eran de tecnología LED y no estaba prevista su modificación, pero finalmente se han sustituido ya que la temperatura de color de los mismos era de 4000K y no cumplían con los niveles de iluminación del proyecto. **Por tanto, se sustituyen 67 PL del estado actual por 67 PL en el estado reformado.**
- ✓ El **CMA 008, con CUPS ES0031103279931001EG0F**, tenía conectadas un total de 177 PL, según se indicaba en proyecto técnico. Durante la ejecución de los trabajos se ha detectado que la luminaria con código 180 no está conectada al centro de mando, es una luminaria particular. Además, no se han detectado 2 PL indicadas en proyecto técnico. Por tanto, el CMA 007 tiene conectados un total de 174 PL. **De los 174 PL existentes en el centro de mando, se actúa sobre el total de PL del cuadro.** Además, durante la ejecución de los trabajos se ha considerado necesaria la inclusión de un PL adicional en una calle previamente iluminada para cumplir con los niveles de iluminación. Con modificación con respecto a proyecto, ya que estaba previsto instalar 177 PL y finalmente se han instalado 175 PL. **Por tanto, se sustituyen 174 PL del estado actual por 175 PL en el estado reformado.**
- ✓ El **CMA 009, con CUPS ES0031103279593001TN0F**, tenía conectadas un total de 203 PL, según se indicaba en proyecto técnico. Durante la ejecución de los trabajos se han detectado 5 PL no contemplados en proyecto técnico. Por tanto, el estado actual tiene 208 PL. **De los 208 PL existentes en el centro de mando, se actúa sobre el total de PL del cuadro.** Además, durante la ejecución de los trabajos se ha considerado necesaria la inclusión de un PL adicional en una calle previamente iluminada para cumplir con los niveles de iluminación. Con modificación con respecto a proyecto, ya que estaba previsto instalar 200 PL y finalmente se han instalado 209 PL, ya que se han sustituido 3 PL que eran de tecnología LED y no estaba prevista su modificación, pero finalmente se han sustituido ya que la temperatura de color de los mismos era de 4000K y no cumplían con los niveles de iluminación del proyecto. **Por tanto, se sustituyen 208 PL del estado actual por 209 PL en el estado reformado.**



- ✓ El **CMA 010, con CUPS ES0031105086984001AK0F**, tenía conectadas un total de 36 PL, según se indicaba en proyecto técnico. **De los 36 PL existentes en el centro de mando, se actúa sobre el total de PL del cuadro.** Con modificación con respecto a proyecto, ya que estaba previsto instalar 29 PL y finalmente se han instalado 36 PL, ya que se han sustituido 7 PL que eran de tecnología LED y no estaba prevista su modificación, pero finalmente se han sustituido ya que la temperatura de color de los mismos era de 4000K y no cumplían con los niveles de iluminación del proyecto. **Por tanto, se sustituyen 36 PL del estado actual por 36 PL en el estado reformado.**
- ✓ El **CMA 011-017, con CUPS ES0031103280127002XE0F**, tenía conectadas un total de 110 PL, según se indicaba en proyecto técnico. Se ha detectado que 2 PL no estaban conectados al centro de mando, por lo que no se han sustituido. **De los 108 PL existentes en el centro de mando, se actúa sobre el total de PL del cuadro.** Además, durante la ejecución de los trabajos se ha considerado necesaria la inclusión de 3 PL adicional en una calle previamente iluminada para cumplir con los niveles de iluminación. Sin modificación con respecto a proyecto, ya que estaba previsto instalar 111 PL y finalmente se han instalado 111 PL. **Por tanto, se sustituyen 108 PL del estado actual por 111 PL en el estado reformado.**
- ✓ El **CMA 016, con CUPS ES0031103279724001SG0F**, tenía conectadas un total de 125 PL, según se indicaba en proyecto técnico. Durante la ejecución de los trabajos se han detectado 4 PL no contemplados en proyecto técnico. Por tanto, el estado actual tiene 129 PL. **De los 129 PL existentes en el centro de mando, se actúa 124 PL del cuadro.** Sin modificación con respecto a proyecto, ya que estaba previsto instalar 124 PL y finalmente se han instalado 124 PL. **Por tanto, se sustituyen 124 PL del estado actual por 124 PL en el estado reformado, quedando 5 PL sin actuación.**
- ✓ El **CMA 019, con CUPS ES0031103279988001QX0F**, tenía conectadas un total de 38 PL, según se indicaba en proyecto técnico. Durante la ejecución de los trabajos se han detectado 2 PL no contemplados en proyecto técnico. Por tanto, el estado actual tiene 40 PL. **De los 40 PL existentes en el centro de mando, se actúa sobre el total de PL del cuadro.** Además, durante la ejecución de los trabajos se ha considerado necesaria la inclusión de un PL adicional en una calle previamente iluminada para cumplir con los niveles de iluminación. Con modificación con respecto a proyecto, ya que estaba previsto instalar 2 PL y finalmente se han instalado 41 PL. 2 PL cuya instalación estaba prevista en proyecto + 2 PL que se han detectado durante la ejecución de los trabajos + 36 PL que eran de tecnología LED y no estaba prevista su modificación, pero finalmente se han sustituido ya que la temperatura de color de los mismos era de 4000K y no cumplían con los niveles de iluminación del proyecto + 1 PL adicional en una calle previamente iluminada para cumplir con los niveles de iluminación. **Por tanto, se sustituyen 40 PL del estado actual por 41 PL en el estado reformado.**

que estaba previsto instalar 31 PL y finalmente se han instalado 31 PL. **Por tanto, se sustituyen 31 PL del estado actual por 31 PL en el estado reformado.**

- ✓ El **CMA 027, con CUPS desconocido**, tenía conectadas un total de 21 PL, según se indicaba en proyecto técnico. Durante la ejecución de los trabajos se ha detectado 1 PL no contemplados en proyecto técnico. Por tanto, el CMA 027 tiene conectados un total de 22 PL. **De los 22 PL existentes en el centro de mando, se actúa sobre el total de PL del cuadro.** Por tanto, el estado actual tiene 22 PL, que se sustituyen por 22 PL en el estado reformado. Con modificación con respecto a proyecto, ya que estaba previsto instalar 21 PL y finalmente se han instalado 22 PL. 21 PL cuya instalación estaba prevista en proyecto + 1 PL que se han detectado durante la ejecución de los trabajos. **Por tanto, se sustituyen 21 PL del estado actual por 21 PL en el estado reformado.**
- ✓ El **CMA 032, con CUPS ES0031103549270005DS0F**, tenía conectadas un total de 71 PL, según se indicaba en proyecto técnico. **De los 71 PL existentes en el centro de mando, se actúa sobre el total de PL del cuadro.** Con modificación con respecto a proyecto, ya que estaba previsto instalar 71 PL y finalmente se han instalado 72 PL. 71 PL cuya instalación estaba prevista en proyecto + 1 PL adicional en una calle previamente iluminada para cumplir con los niveles de iluminación. **Por tanto, se sustituyen 71 PL del estado actual por 72 PL en el estado reformado.**
- ✓ El **CMA Norias, con CUPS ES0031105212948001PJ0F**, tenía conectadas un total de 33 PL, según se indicaba en proyecto técnico. Durante la ejecución de los trabajos se ha detectado 1 PL no contemplados en proyecto técnico. Por tanto, el CMA Norias tiene conectados un total de 34 PL. **De los 34 PL existentes en el centro de mando, se actúa sobre el total de PL del cuadro.** Por tanto, el estado actual tiene 34 PL, que se sustituyen por 34 PL en el estado reformado. Con modificación con respecto a proyecto, ya que estaba previsto instalar 33 PL y finalmente se han instalado 34 PL. 33 PL cuya instalación estaba prevista en proyecto + 1 PL que se han detectado durante la ejecución de los trabajos. **Por tanto, se sustituyen 34 PL del estado actual por 34 PL en el estado reformado.**

2.3 RESUMEN DE LAS ACTUACIONES PROYECTADAS

La actuación consiste en la reforma de las instalaciones de alumbrado público exterior por tecnología LED e implementación de un sistema de telegestión, en los núcleos de Puebla de Don Fadrique y Almaciles, en el T.M. de Puebla de Don Fadrique (Granada).

Se ha procedido a la renovación de los 1.015 puntos de luz, sustituyéndolos por 1.024 puntos de luz (para dar cumplimiento al REEIAE, ha sido necesaria la instalación de 9 puntos de luz adicionales) y se han reformado 16 centros de mando (dos de ellos presentan subcuadro, por lo que se han reformado



un total de 18 cuadros de mando), así como la implantación de un sistema de telegestión en cabecera en cada uno de los centros de mando junto con la implementación de telegestión punto a punto.

La instalación reformada cuenta con las siguientes características:

3 PLAN ESTRATÉGICO

3.1 ORIGEN O LUGAR DE FABRICACIÓN

A la hora de elegir los diferentes componentes de la nueva instalación, se han buscado fabricantes nacionales, con los centros de fabricación en España.

En principio, la actuación se ha diseñado con alternativas de dos fabricantes nacionales como son:

- SIGNIFY IBERIA, S.L.U., establecida en CL MARÍA DE PORTUGAL, 1 – 28050 MADRID y CIF B47002811, cuenta con una fábrica en Valladolid con más de un siglo de experiencia en el ámbito de la iluminación exterior de espacios públicos.

IMPACTO MEDIO AMBIENTAL:



El impacto medioambiental de los componentes de la instalación se minimiza por las siguientes premisas:

Se optimizan los costes y emisiones del transporte al elegir productos con centros de fabricación nacionales.

El fabricante elegido cuenta con un sistema de gestión medioambiental certificado según la Norma UNE-EN ISO 14001:2015 (Se adjuntan certificados del sistema de gestión medioambiental).

Los productos empleados usan aluminio reciclado prácticamente al 100%, cuenta con certificado de ciberseguridad (proceso de desarrollo de productos seguros), es miembro de la Asociación Española de Fabricantes de Iluminación (ANFALUM) y está adherida a la asociación AMBILAMP (en virtud de contrato de adhesión, al sistema colectivo de responsabilidad ampliada del productor de los residuos de aparatos eléctricos y electrónicos del Real Decreto 110/2015, de 20 de febrero (RD RAEE) operado por esta Asociación, en cumplimiento de sus obligaciones como productor de Aparatos Eléctricos y Electrónicos (AEE), y con número **RII-AEE 6000**)

3.2 CRITERIOS DE CALIDAD Y DURABILIDAD

El fabricante de los productos elegidos garantiza el cumplimiento de los más exigentes estándares de calidad en sus procesos de fabricación y en sus productos acabados.

Todos los materiales serán suministrados con una garantía mínima de 10 años.

Los fabricantes elegidos cuentan con un sistema de gestión de la calidad certificado según la Norma UNE-EN ISO 9001:2015 (Se adjuntan certificados del sistema de gestión medioambiental).

3.3 IMPACTO SOBRE PYMES Y AUTÓNOMOS

A la hora de la realización de la actuación, la misma ha tenido un impacto muy positivo sobre PYMES y autónomos.

Se han contratado empresa y autónomos locales a la hora de llevar a cabo la ejecución de las obras.

En particular, se espera un impacto positivo para las siguientes empresas a nivel local:

- PYMES y autónomos locales dedicadas a trabajos de movimiento de tierras.
- PYMES y autónomos locales dedicadas a trabajos de albañilería.
- PYMES y autónomos locales dedicadas a servicios de transporte.

A nivel regional y nacional, es evidente el impacto positivo que la actuación generará en las industrias de fabricación de componentes para la instalación (cables, materiales para luminarias, pequeño



material...), unido a las empresas de transporte nacional que se encargarán de suministrar todo el material a los puntos de fabricación y de éstos al lugar de la obra.

3.4 IMPACTO SOBRE EL MUNICIPIO Y EL ENTORNO

La actuación ha generado un impacto positivo sobre el municipio y el entorno en términos sociales y en particular, en relación con el reto demográfico, así como ambientales y económicos.

Ya se ha comentado el impacto positivo sobre PYMES y autónomos locales, sobre los que recae la importante tarea de contratación de la mayoría del empleo local en el medio rural.

Por otra parte, el ayuntamiento de un municipio de 2000 habitantes va a ver reducida su factura energética en un porcentaje superior al 70%, lo que se traducirá en una disponibilidad de fondos para otras inversiones y servicios necesarios en el municipio.

Además, con la actuación pretendida se pretenden dar soluciones de iluminación para exterior que mejoren el entorno nocturno del municipio, pues a través de la luz se puede mejorar la calidad de vida de las personas, impactar positivamente en la sociedad y transformar espacios, ciudades y el planeta.

Finalmente, indicar que, con la actuación no solo se ha reducido la factura económica del Ayuntamiento, sino que se ha reducido el consumo energético con las correspondientes reducciones de emisiones de CO₂, colaborando a la lucha contra el cambio climático. Además de la reducción de emisiones, se ha cuidado mucho la contaminación lumínica en un municipio donde la calidad del cielo nocturno es uno de los principales activos con los que cuenta, existiendo incluso un observatorio astronómico en su término municipal adherido al Instituto Astrofísico de Andalucía.

En definitiva, con la actuación propuesta, se contribuye a la mejora de la calidad de vida de los habitantes del municipio, contribuyendo de esta forma en la lucha contra la despoblación, suponiendo un impacto positivo para el reto demográfico.

3.5 PLAN DE FORMACIÓN DEL PERSONAL ADSCRITO A LAS ENTIDADES LOCALES

Tras acometer la actuación que nos ocupa, será necesaria la formación del personal de mantenimiento de las instalaciones de alumbrado municipales para su instrucción y adaptación al sistema de telegestión implantado.

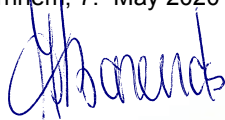
